This form, together with your application fee, formally registers your child in Aldrich for the coming school year. Tuition has been set at a level monthly payment for your convenience. In June you will be mailed a coupon sheet. September's tuition is due in mid July and October's tuition is due by your child's first day of school in September. Subsequent payments are due one month in advance on the first of the month, through April. If your child is absent due to illness or vacation, payment is still required. No additional notice of payment due will be sent. Checks are to be made payable to Aldrich.

In April 2006, the Board of Directors approved the following payment policy. If your payment is delinquent, you will receive notice on or about the 10th of the month that the payment is due and a \$10 late fee has been assessed. If payment is not received by the 20th, you will receive a second notice advising that your account has been referred to the Executive Committee of the Board of Directors. The Executive Committee will have full authority and discretion to take action on your account, including, but not limited to disenrollment.

This agreement may be terminated via 30 day written notice. The application fee paid at the time of enrollment is non-refundable. Any tuition paid before the 30 day notice is given is non-refundable. *Your signature below constitutes a contract between us.*
